## Pregnant Parenting Intervention (PPI) Case Manager

### Description

The Pregnant Parenting Intervention (PPI) program provides Intervention services aimed at reducing the impact, severity, and cost associated with a substance exposed pregnancy to the mother and child dyad and their Families by offering comprehensive Case Management services, Community-Based linkage and retention services, supports for family members/significant others and Evidenced-Informed education for mothers who report a past and/or present Substance Use Disorder (SUD) diagnosis.

The Care Manager will work directly with pregnant women, who reside in Texas, who report a past or present SUD, and her family members. The Case Manager will work with Child Protective Services, treatment centers and other community-based organizations in Bexar County to deliver intervention outreach services. This is a five-year grant funded program.

### Core Duties

- Screen program participants to ensure that required program criteria are met.
- Complete assessments for Parents referred to PPI Program.
- Create service plan for Parents enrolled in PPI Program.
- Create referrals and follow ups to other social services for Parents in PPI Program as part of their continuum of care.
- Provide Case Management for Parents to ensure wrap around services are obtained.
- Provides both monthly, quarterly, and annual written and oral reports concerning program activities and evaluation information to the Program Director.
- Attends staff meetings and works with Director on process, outcome, evaluation, and the development of activities to meet program goals.
- Provides both written and oral reports concerning program activities and evaluation information to the Program Director.
- Learn and thoroughly understand the philosophy of the Council, its programs and services and resources available offenders, spouses, and children.
- Provide education support included but not limited to, tobacco cessation, life skills training, overdose prevention education, substance use and trauma, and aspects of prenatal and postpartum care.
- Facilitate contacts with other people to promote learning of social and recreational skills, create community and acquire a sense of belonging.
- Work independently in community settings, including surrounding counties,
